Payment Terms

All orders are to be pre-paid until credit has been established. First time customers are required to pre-pay the order.

Credit

Once Credit has been established, terms are NET 30 FIRM from the date of shipment. Past due invoices will be billed for interest at a rate of 1.5% per month.

Discounts

Pre-paid orders are discounted 5% once credit has been established.

Taxes

Any and all taxes are the responsibility of the buyer. NH does not have a state sales tax.

Shipping

Freight charges are billed to the purchaser. All shipments are FOB Semper Fi. Carrier determined by factory. The factory must be consulted if a specific carrier is required.

Claims

All products are packed to comply with UPS requirements. Semper Fi is not responsible for damage to goods in transit. It is the purchaser's responsibility to examine goods upon receipt and to file all claims with the carrier. Any claim for manufacturing defects, shortages, or order errors must be made in writing within 10 days. Failure by the seller to make any claims within 10 days constitutes acceptance of the goods and a waiver of any defects, errors, or shortages.

Prices

Prices do not include shipping, handling, storage, taxes, or installation. All prices are subject to change without notice, prior to confirmation of the order.

Ordering Procedure

All orders must be submitted in writing to avoid error and/or duplication. Telephone or verbal orders will not be accepted.

Custom Orders

All custom orders require a 50% deposit at the time of order, which may be forfeited if the order is cancelled or changed.

Large Orders

All units are built to order, therefore all orders over \$20,000 require a 25% deposit at the time of the order, which may be forfeited if order is cancelled or changed.

Terms of Sale

The terms and conditions of the sale will comply herewith and can't be changed by the acceptance of a purchase order with different terms and conditions.

Returns

No returns will be accepted unless an RA number has been issued by the factory and is clearly marked on the returned item.

Restocking Charges

Returns of non-defective goods, if approved, must be done within 30 days of original shipment and are subject to a 50% restocking charge.

Warranty

All Indoor units are fully warranted for 25 years from date of original shipment. *Outdoor units are fully warranted for 10 years from date of original shipment.* This warranty covers only properly installed units used under specified conditions. Semper Fi will, at its option, repair or replace defective units provided that they are returned to the factory and an inspection determines the unit to be defective under the terms of the warranty. Repair or replacement, as stated above, shall constitute the purchaser's exclusive warranty, which does not extend to transportation, installation, labor, or any other charges; nor does it apply to any equipment of another manufacturer used in conjunction with products from Semper Fi.

Product Specifications

Semper Fi reserves the right to change, at any time and without notice, the technical and/or design specifications of any product listed on the price list.

Arbitration

The laws of the state of New Hampshire shall govern any arbitration between seller and buyer.
